### REGULATIONS OF THE "HALLOWEEN 2022" PROMOTION

# §1. Definitions

The definitions used in these terms and conditions (hereinafter: "Terms and Conditions") refer to:

- 1. "Campaign's home page" the www.maxtondesign.com website;
- 2. "Organizer" the organizer of the promotion Maxton Design Piotr Kardaś with its seat in Wojnicz, ul. Podlesie 26, 32-830 Wojnicz;
- 3. "Promotion" the Halloween 2022 promotion carried out on the terms set out in these terms and conditions, which can be found in the HALLOWEEN tab on the main page of the campaign;
- 4. "Participant" an adult natural person with full legal capacity, participating in the promotion, and a legal person, as well as an organizational unit with legal capacity;

### §2. General provisions

- 1. The promotion is run by the organizer from October 31, 2022 at 00:00 (UTC +01:00) until November 2, 2022 at 23:59 (UTC +01:00), exclusively via the campaign homepage. The organizer has the right to end the promotion early, about which he will notify the participants via a message on the campaign's home page.
- 2. The amount of the discount granted to individual customers is determined by the Organizer and amounts to 20% for Maxton Merch clothes from the Maxton Design offer.
- 3. The organizer grants an additional discount for wholesalers / dealers, and the amount of the additional discount is determined individually for each dealer.

## §3. The aim of the promotion

- 1. The aim of the promotion is to provide its Participants with the opportunity to purchase the product offered by the Organizer in its online store at promotional prices obtained using a discount code, in accordance with the Regulations, which can be found in the "Halloween" tab on the Campaign website.
- 2. The promotion is organized for individual customers and wholesale customers / dealers of the Organizer in order to sell the inventory of products from the Maxton Merch collection from the Maxton Design collection.

## §4. Terms and conditions of participation in the promotion

- 1. Participation in the Promotion is voluntary.
- 2. The condition for taking part in the Promotion is accepting the Regulations, taking up the activity specified below and purchasing the product covered by the Promotion. By placing an order, the promotion participant accepts the Promotion Regulations, which can be found in the "Halloween" tab on the main page of the Campaign.

# §5. Terms and conditions of participation in the promotion for wholesale customers/dealers

- 1. Participation of the wholesale customer / dealer in the Promotion is voluntary.
- 2. A wholesale customer / dealer may place an order with the Organizer within the period from October 31, 2022, from 00:00 (UTC +01:00) to Novwmber 4, 2022 at 23:59 (UTC +01:00). Orders placed before and after the designated date will not be eligible for the Promotion.
- 3. Participation in the Promotion for a wholesaler / dealer will be possible by increasing the discount to a certain value.
- 4. The participation of the wholesale customer / dealer in the Promotion is subject to acceptance of these Promotion Regulations.
- 5. The Organizer reserves the right to verify the activities performed by the wholesale customer / dealer related to the Promotion, including:
  - a) verification of the compliance of activities with the provisions of these Regulations;
  - b) verification of the method of promotional sale of products;
  - c) verification of the time when the order of the wholesale customer / dealer was placed;

### §6. Purchasing discounted products

- 1. In order to purchase a product offered for sale as part of the Promotion directly in the Organizer's online store, active at https://www.maxtondesign.com, the following steps must be taken:
  - a) enter the website at https://www.maxtondesign.com;
  - b) Place an order in accordance with the stages of the Organizer's online store, after selecting the products, in the "Cart" tab, enter the rebate code in the field provided for this purpose, and then confirm the code by clicking the "Confirm code" button.
- 2. The contract for the sale of the product covered by the Promotion is concluded when the order is successfully placed in the Organiser's online store at https://maxtondesign.com.
- 3. The Organizer may end the Promotion before its official end in the event that all products covered by the Promotion are sold. The Organizer will inform the customers about the early termination of the Promotion through the relevant information on the Organizer's website.

- 4. The moment of completing the order for the product covered by the Promotion is assessed according to the real time of completion by a given Participant. If the information about the order is received by the Organizer after October 31, 2022, at 23:59:59 (UTC +01:00), while the Participant has made an attempt to order in a timely manner, any doubts as to the timeliness of placing the order will be immediately considered in favor of the Participant after analyzing the evidence presented by him for confirmation of the time placing an order.
- 5. Any disruptions, and in particular delays in the operation of the ICT network, adversely affecting the placing of an order under the Promotion, will be considered in favor of the Participant, in accordance with the circumstances of the disruption, which applies only to orders effectively placed during the Promotion. the duration of the Promotion.
- 6. The Organizer is not responsible for errors and disruptions related to failures not directly related to the website https://maxtondesign.pl and not attributable to the Organizer.

# §7. Exclusion from participation in the promotion

- 1. The Organizer has the right to exclude the Participant with immediate effect from participation in the Promotion in the event of failure by the Participant to comply with the provisions of the Regulations, as well as in the event of receiving information about actions contrary to the provisions of the Regulations or the purpose and idea of the Promotion.
- 2. Act contradicting the provisions of the Regulations or the purpose and idea of the Promotion are, in particular, activities aimed at or resulting in the purchase of products covered by the Promotion:
  - a) in a manner other than indicated in §6 of the Regulations;
  - b) by using errors in the operation of the Promotion system, its website or Mobile Application.

### §8. Procedures for submitting and considering complaints regarding the promotion

- 1. Complaints regarding the course of the Promotion should be submitted in writing to the following e-mail address:
  - a) individual customers: sales@maxtondesign.eu;
  - b) wholesale customer / dealer: info@maxtondesign.eu.
- 2. The Participant has the right to submit a complaint regarding the mechanism and mode of operation of the Promotion within a maximum period of 5 days from the date of the event.
- 3. The complaint should include the name, surname, exact address of the Participant submitting the complaint, as well as a detailed description and indication of the reason for the complaint, indicating the date of the event covered by the complaint. Messages that do not meet these criteria will be automatically rejected.
- 4. Complaints will be considered within 14 working days from the date of receipt of the complaint by the Organizer.

# §9. Final provisions

- 1. The Regulations are available on the website and at the Organiser's office.
- 2. The Regulations are valid from October 31, 2022 at 00:00 (UTC +01:00) to November 4, 2022 at 23:59 (UTC +01:00).
